## John Brunsdon

It was with great sadness that trustees learned of the death of one of our founder members and most committed supporters.

Retired veterinary surgeon John Brunsdon was a man of considerable energy – until recent years he walked up Glastonbury Tor every day – and possessed a delightful sense of humour.

John was a member of Glastonbury Town Council for 44 years and twice served as Glastonbury Mayor in 1980 and 1983. He also served for many years as a Mendip District Councillor and County Councillor.

He was a member of the Mendip Conservation Advisory Panel and took a particular interest in architectural conservation.

In November 2001, he was awarded the MBE for conservation services in Glastonbury and received his award at Buckingham Palace from the Prince of Wales.

John was also a National Trust Tor warden and served as President of the Glastonbury Conservation Society. In recent years he had been advising on the restoration of footpaths in and around Glastonbury.

## Tone Mill

Members will have been pleased to hear that Tone Works, on the outskirts of Wellington, has been given a £348,000 grant by Historic England to fund the first phase of work to restore the former cloth finishing works and give it a new role in the community.

Tone Mill, which dates back to 1796, was part of the Fox Brothers textile company and a major employer in Wellington. When the works closed in 2000, most of its traditional textile machinery and equipment remained in place, with part-processed pieces of cloth still on the machines.

SBPT's former chairman Mike Foden and secretary Erica Adams set up a charitable trust and initiated a feasibility study with the aim of saving the buildings and finding a new role for them. Unfortunately, despite all their hard work, the plan had to be shelved, due to a lack of support from various external organisations.

This new grant, part of the government's Cultural Recovery Fund, has revived ambitions to preserve this important example of the county's industrial past.

It is planned to turn it into a resource for local groups and, taking advantage of its proximity to the River Tone, create a wildlife-rich environment.

## Sandhill Park

The long and sorry saga of the vandalised and fire-damaged historic mansion at Sandhill Park, Bishops Lydeard, looks set to continue for a little longer.

Talks involving Somerset West and Taunton Council and the administrators, are still going on. The SBPT has been included in some of these discussions and has offered advice on aspects of the project.

We hope that these negotiations will result in a resumption of work to give a new lease of life to the Grade 2 listed building which dates back to 1720 and has such a long and colourful history.

## Bishops Barn

The 15th century tithe barn in Wells, thought to be one of only 200 great barns remaining in the country, is set to be returned to the local community.

Mendip District Council has voted to transfer the barn to Wells City Council. This will require the permission of the Charity Commission which has said it would look favourably on the request.

The SBPT is supporting Mendip's application. It is felt that the more local management structure offered by Wells City Council is the right solution for the Barn's future.

The barn, a Grade 1 Listed building and Scheduled Ancient Monument, was gifted to the citizens of Wells in the late 19th century for community use. It came under the control of Mendip District Council with the reorganisation of local government in 1974.



## Stansell Awards

Our plans to hold a special ceremony to mark the 20th anniversary of the launch of the Stansell Awards sadly had to be postponed. We are hopeful we may be able to stage the awards this autumn although it will depend on the national Covid guidelines.

The new closing date for entries is May 7 2021. Those projects that had already been entered for the 2020 event do not need to re-apply.
